## Rules and Liability Statement for the NM Growers Cup

**THC and CBD Flower: 10 single gram** jars or baggies of your chosen strain. Entries are judged upon appearance, taste/smell, Smokeability, and effects. Pick your 10 best 1-gram buds for entry. Attach a copy of the grower registration form or your name and strain info.

**Concentrates: 10 single gram packages** or jars of your chosen strain. Attach your grower registration form or name and strain info.

**Edibles: 10 individually packaged doses** of your chosen entry. Enclose an ingredient list with your grower registration form. Make sure to enclose any care instructions i.e., should they be frozen or warmed up.

**Topicals: 10 individual jars** of your chosen salve. Enclose your grower entry registration form with your name and strain info along with ingredient list.

**Collections - Please provide 10 - 3 products kits**, all using the same strain. The 3 different products can be from any of the categories above, 3 different products such as edible, flower, concentrate, topical. It must all be made with the same strain. This will show the diverse benefits of this strain.

**Scoring:** There will be 6 Judges, each entry can score a maximum of 30 points per individual judge. Once the entries are scored, those scores go on the master sheet to be combined. Max Score Total is 180. Top 3 entries from each category will be awarded.

All consumption of products on site must be done within the walls of the venue and consumed responsibly. The venue and the New Mexico Growers Cup and all entities associated bear no responsibility for your individual consumption, injury, issues, or theft from the venue and/or parking lot. You are responsible for yourself and your belongings, please keep track of them. Must be 21 years of age or older unless accompanied by an adult.
